

AMAZON THINK BIG COMMUNITY CHALLENGE 2026

MASTER PARTICIPATION AGREEMENT

PARTIES: (1) **Creative Hut Ltd** ("the Organizer"), operating on behalf of **Amazon Web Services** ("AWS"). (2) _____ ("the School").

1. PARTICIPATION MANDATE: The School agrees to participate in the Think Big Community Challenge 2026 (the "Challenge") and ensure all student activity is conducted in accordance with the **Challenge Rules and Privacy Policy** as published on the official challenge website. The School acknowledges that these Rules may be updated periodically by the Organizer.

2. DELEGATED CONSENT & AUDIT: The School agrees that it will ensure all students participating in the Challenge have signed Parental Consent Forms ("Parental Consent Forms" means, collectively, the Terms & Conditions, the Intellectual Property License Agreement, and the Media Release provided by the Organizer) on file, and that as the primary Verification Agent (defined below), it has properly verified each student's age and confirmed the identity of the signing legal guardian prior to student participation.

- **Verification:** The School will act as the primary "Verification Agent", using official enrolment records to confirm student age and the identity of signing legal guardians.
- **Collection:** The School will secure and archive the Parental Consent Forms .
- **Audit:** The School will retain the Parental Consent Forms for **three (3) years** and provide a copy of any requested Parental Consent Forms within **five (5) working days** for legal or audit purposes.
- **The Manifest:** The School agrees that App PIN codes will only be released by the Organizer upon receipt of a completed **Participation Manifest** (the digital workflow tool provided by the Organizer used to verify the collection of parental consent forms and to share back Challenge App anonymized IDs and access PIN codes).

4. LIABILITY & INDEMNITY

- **School Responsibility:** The School assumes liability for the accuracy of the Parental Consent Forms collected and agrees to indemnify the Organizer and AWS against any claims arising from a failure to secure valid legal permissions or verified identities as required by local law.
- **Organizer Responsibility:** The Organizer's liability for any claim arising from the Challenge logistics or the use of the App is limited to the value of the prize/reward or the school's direct participation costs, whichever is lower.
- **General:** Neither party shall be liable for indirect or consequential losses.
- **Financial Integrity:** The School warrants that any prizes or rewards issued will benefit the student contestants or the School directly. The School ensures that participating teachers shall not receive any personal economic benefit from their students' participation.

5. PRIZES, FULFILLMENT & WINNER PUBLICITY

- **Prize Allocation:** All prizes, including the winner's tour/trip, are awarded exclusively to the student contestants or the School.
- **Winner Identification:** While the Challenge is conducted via anonymized IDs, the School agrees to disclose the real identity and contact details of winning students to the Organizer for the sole purpose of prize fulfilment (including travel arrangements and safety documentation).
- **Winner Publicity:** The School acknowledges that winning students may be required to participate in promotional media activities related to the prize trip as a condition of acceptance.

6. GOVERNING LAW This agreement is governed by the **laws of England and Wales**.
